### **2024 ANNUAL MEETING MINUTES**

Sunday, January 28, 2024

### Call to Order

- Called to order by Tony Belcher at 10:44am.
- 38 voting members in attendance

### Prayer

### Approval of Minutes from 2023 Congregational Meetings:

- Annual meeting of January 29, 2023
- Special congregational meeting of April 16, 2023
   Motion to approve the meeting minutes from both the Annual Meeting on January 29, 2023, and the Special Congregational Meeting on April 16, 2023, by Steven Stubbs.
   Second Beth Schoening. Approved.

### **Reports:**

- President
  - Tony Belcher reported he has seen a lot of growth in 2023 not only in new faces and families but also the opening of Brighton Academy North offering invaluable daycare services to our community.
- Pastor
  - Pastor Mike described Hosanna! as being more active, connected and engaged as a congregation.
  - 2023 Parish Statistics new faces and families added this year along with three baptisms, six youth participated in their first communion, and a wedding in November. We grieve with the loss of two members by death and those who have left or moved away. New to membership status this year is active friends line item. We have 31 friends who worship and participate in activities. In person attendance has stayed about the same with some members continuing to worship online.
  - Pastor Mike encouraged the congregation to read the information included in the report from the Central States Synod and messages from Bishop Susan Candea, CSS and Bishop Elizabeth Eaton, presiding Bishop of ELCA.
- Sabbatical Committee Report
  - Tony Belcher stated that Pastor Mike is overdue for a sabbatical. A Sabbatical is a designated time for the pastor to step away from their usual duties and engaged in activities that promote personal and professional renewal, rest, and reflection. Tony reported that a Hosanna! Sabbatical Committee has been formed and is working on putting together an application to submit by March 2024 for financial reimbursement via the Lilly Endowment Clergy Renewal Program to help offset the costs and events and programs the pastor plans to attend during his sabbatical (to occur in 2025) as well as costs the congregation would encounter during this time.

- Office Administrator Report
- Faith Formation
  - For the 2023-2024 school year, we continue to use a blended model that incorporates intergenerational learning, service projects, small groups, and more traditional agebased classes.
  - Thrilled to have Dr. Marple and Mitchell leading music time twice a month for our kid's crews and to see several of our tweens and teens singing with the adult choir.
- Evangelism
  - Pastor Mike talked about this year the plan is to keep building on the more "traditional" evangelism avenues, and we encourage you to consider who and how you can invite those you already know to reconnect with God and the church.
- Property
  - Scott reported that we now have a new roof, and larger gutters, with some screens and siding being repaired.
  - Other projects on the horizon: replacing 10 columns with PCV, trash enclosure gates, and floor tile replacement.
  - ° Outside yard maintenance help is always needed.
  - A HUGE Thank You to Steve Friends, who helps with keeping the inside clean, to Cathy for ordering supplies and Pastor Mike who helps with small projects that need to be repaired. And thank you to everyone behind the scenes for your time and assistance in maintaining the church.
- Brighton Academy North
  - Brighton Academy North opened their doors on September 5 with an initial enrollment of 23 children. Current enrollment is up to 40 with more expected between March and April, leaving a limited seven spots available for the remainder of the school year. This has been a great partnership and with the growth this signifies their dedication to providing a nurturing educational environment for the youth.
- Social Ministries
  - <sup>°</sup> Joyce Uber thanked the congregation for their generosity this past year and mentioned the upcoming Valentines for Veterans event on Feb 11.
- WELCA
  - Karen Orrill mentioned there are currently 10 members of the Shirley Circle that meet once a month at her home. All women are welcome to join the meetings and other events held by the Women of the ELCA.
  - <sup>o</sup> Four members of the Shirley Circle attended the 35<sup>th</sup> Annual Central States Synod WELCA convention in June in Independence. The theme for the convention was "The Lord is My Light" and was woven throughout the weekend with Bible studies, guest speakers and Christmas services. A business meeting was held to handle business and elect officers. Louise Ahrens was elected to serve on the board of CSS WELCA. She served as an at-large delegate for the 2023 Triennial meeting and attended the national

WELCA gathering in September in Phoenix.

- 2023 projects consisted of: Project for Once We Were Refugees (OWWR), Gift Cards for School teachers, In As Much Ministry, Love, Inc., and MLM.
- God Squad
  - Sarah reported an account was opened at the Pony Express Bank for the Hosanna! God Squad on Dec 22, 2023, with an opening balance of \$2,265. This amount along with the Youth Fund (listed separately in the Treasurer's report) of \$8,896 (which will be transferred to the God Squad account) will total \$11,161 and is sufficient to cover the cost for 5 youth and 2 adults to attend this year summer's National Youth Gathering in New Orleans.
- Prayer Weavers
  - Tony reported that the group made and donated 1,171 crochet blankets (roughly 93 blankets a month) to Children's Mercy Hospital, Children's Mercy Hospital Northland Clinic and other facilities that wish to remain anonymous. He thanked the group for their hard work and dedication to this worthwhile project.
- Worship and Music
  - Pastor thanked and acknowledged the congregation members that helped with music during the transition of Dr. Dan leaving and hiring Dr. Chris Marple as Choral Director and Michell Jerko as our Organist/Pianist.
  - Dr. Chris talked about the upcoming Lenten Wednesday evening services which will feature Holden Evening Prayer, and the choir will present an Easter Cantata on April 7.
- Stewardship
  - Robert Hall mentioned last fall that he, Pastor Mike, and Louise Ahrens attended an online Stewardship course hosted by the ELCA, in partnership with the Lake Institute – Cultivating Generous Congregations.
  - He also talked about the purpose of the new pair of bulletin boards in the entryway. These bulletin boards are to be used by the congregation to share stories of generosity both of how someone else's generosity has positively impacted your life or how you will intentionally spread generosity.
- Treasurer's Report Account Balances
  - Ben talked about how the 2023 budget was originally projected to be a deficit of 44K but ended with only a deficit of 2K! A huge thank you to the generous giving of the congregation. He discussed the checking account balances and reviewed the historical income/expenses plus 2024 budget.
  - He thanked Don Summers for setting up the new Breeze software and mentioned that anyone still using Vanco to please switch over to Breeze.

### FROM THE CENTRAL STATES SYNOD

In the gospels, particularly in the sermon on the mount, Jesus doesn't call us to resolve to be peacemakers, to hunger and thirst for justice, to be meek, to be children of God. He simply says we are. Jesus doesn't tell us we ought to be salt for the earth, and light for the world in order to be saved. He says, "You are the salt of the earth. You are the light of the world," in order to participate in God's salvation and redemption of the world.

In the ancient world, salt was a sacred commodity. It was used to preserve food and to heal. It didn't just add flavor. It literally brought life. In a world where darkness was frightening and dangerous, unable to see the threats that lay in wait, light brought peace and hope. As people of God, that's who we are – instruments of life and healing; people who embody peace and hope; salt and light.

As we enter into the new year, I believe it is more imperative than ever that we claim and live our identities as salt and light. In a culture that equates greatness with power, we define it by humility and service, and we emphasize sharing over greed and the accumulation of wealth. We



proclaim truth rather than rhetoric, that diversity is to be celebrated and respected rather than met with suspicion and disdain; that integrity is more important than image. We stand with and for the good of our neighbor rather than individual privilege. We are beautiful, brave, and kind in a world that is often ugly, scary, and mean.

Going forward, how will we be the salt and light the world needs? While we continue to have different views on the complex issues we grapple with as a nation, we cannot abdicate our identity as truth-tellers and love-bearers. We are the salt of the earth. We are the light of the world. This is about following the way of Jesus, joining God's reign of justice in the world, and loving our neighbors.

And finally trust that you are, that we are, salt and light. We will be no less in the coming year.

### **FAITH FORMATION**

### Faith Formation Forges Friendships

2024 was a great year for our faith formation programs. We continued a monthly pattern of different styles of learning to provide opportunities that appeal to everyone. Each month typically included:

- Age-based groups on the 1st and 3rd Sundays: Kids Crews for PreK-5th graders, Confirmation for 6th-9th, and God Squad periodically for high schoolers. Adults met with Pastor Mike or Pastor Kreidler for Bible study/learning.
- Service projects on the 2nd Sunday: All members were invited to join in a project that helps meet a need, including Valentines for Vets, MLM, In As Much food pantry, caring for the church building and grounds, and creating collaborative art pieces.
- Connect week on the 4th Sunday: Individuals with a particular talent or expertise shared their knowledge with interested adults, parents and caregivers met to discuss the joys and challenges of raising children, and youth led the kids in activities that related to their Bible story/theme of the month.

Our kids also had fun:

- Singing with Dr. Marple on Kids Crews weeks and sharing music in worship.
- Performing a Christmas program, "A Very Mixed-Up Christmas Pageant."
- Playing together at Hosanna Day, Rally Day, and other family events.
- Building new friendships with people of all ages in our Hosanna! family.

Worship activities such as art supplies, labyrinths and fidgets continued to be a popular part of the Sunday morning experience for many members. We also saw a lot of interest and use in our new Sensory Room, which provides a quiet and comfortable space for kids to decompress when the joyful noise gets to be a bit too much.

Last year we had a lawnmower that was donated and Mike Jennings has been helping keep the outside trimmed up. While we have a lot of property, Mike could use some assistance when it comes to trimming up around the outside. More will come as the weather turns warmer again.

As last year was pretty quiet, we had some minor door repairs, trimming up trees and bushes, and repair the windows. A few things that didn't get done last year will hopefully be targeted for this year. ### **2024 Social Ministry Activities**

Hosanna! continues to be a generous congregation with the following activities this year:

Monthly food and non-perishable items were collected and delivered to In as Much Ministry in Liberty

In February, we collected, assembled and delivered 125 hygiene care packages for Valentine's for Veterans project. The Sunday school children made valentines which were included in the care packages. These packages were delivered to the VA in Excelsior Springs.

On Palm Sunday in March, Hosanna members made and sent handmade greeting cards to members and friends who have moved away in the past years.

In May, Hosanna! families assembled water filters for Wine to Water, a non-profit organization working in 53 countries around the world to improve access to clean water.

In July Hosanna members assembled and handed out sack lunches for the Gathering Table Sack lunch Project.

Also, in July and again in November – the MLM Christmas Tree was put up in the Fellowship Hall and members donated items which were delivered to the MLM Christmas Store.

September/October - A group from Hosanna! participated in Rebuilding Together Day

October – Four members of Hosanna participated in the Alzheimer's Walk

Our Children's Offerings collected this year went to support:

- Purchasing of fruit trees for communities around the world facing food shortages
- Warrior's Best Friend, a nonprofit organization located behind Hosanna that trains shelter dogs to become facility dogs for military organizations and K-12 schools
- Lutheran Disaster Response to help people impacted by this year's hurricanes

### THE GOD SQUAD

At the end of 2023 Pastor Mike and Sarah Read (Treasurer) were able to open a specific checking account for the God Squad with the generous fundraising proceeds from the Treat Trays for a beginning balance in the checking account in 2024 of \$2,265. Through the previous and ongoing generosity of our Hosanna! Congregation we were able to transfer over \$9,554 making our total \$12,450.74 at the end of the First Quarter 2024, This total was able to financially support 5 Youth, I adult participant, and Pastor Mike for the entirety of the trip to the Youth Gathering in New Orleans LA which included transportation, hotel accommodations, and activities for a total of \$8,368.59 spent leaving \$4,082.15 in the checking account.

The God Squad participated in a number of fundraising events in 2024 beginning with a joint effort with St. Stephan's Lutheran for the Shakespeare's Superbowl Pizza event, the Valentine's Day Lasagna Dinner, Palm Sunday Pie Auction, Thanksgiving Pies, and the famous Treat Trays to

round out 2024 with the ending balance in our account of \$6,509.15. The focus for the God Squad shifted slightly to Volunteer and Community outreach partnership for the end of 2024 and the year of 2025. The God Squad is regularly participating in Bible School for the younger youth and will continue to partner with local Law Enforcement for joint community projects such as Trunk or Treat and Rally Day.

### **POTENTIAL LAND SALE UPDATE**

On September 15, 2024, the congregation voted to authorize the Congregation Council to sell or encumber up to 3.25 acres of land bordering the west perimeter of our property. Here are some developments since that time:

- Verbally communicated intentions to Chalky Mountain Gymnastics
- Began legal process to de-annex land from Kansas City and annex it into Liberty, putting all our land in Liberty (including some land not being considered for sale).
- Met with Gale-Hart Communities, who will be developing the area around the church. Discussed road studies already completed and verbally agreed to include an entrance to our west property when 104th Street is redeveloped.
- Received verbal confirmation that both cities are open to the jurisdiction transfer.
- KCMO notified us that our 2015 land purchase was never recorded with Kansas City (it was recorded with Clay County), and this must be resolved before de-annexation. Advised that we need to perform a minor subdivision and inter-jurisdictional plat.
- Reviewed title insurance, which was found not to cover this oversight.
- Sought legal counsel on replat. Received additional counsel on how to structure a sale to protect Hosanna in case of a buyer default.
- Approached Chalky Mountain about a lump-sum sale offer. Council reviewed offer and decided original owner-financed sale would be the preferred path forward.
- Contacted previous land owner for assistance with the replat. Received little.
- J & J Survey conducted the plat survey and is currently finalizing the paperwork.
- Chalky Mountain Gymnastics is graciously waiting patiently. *Expected actions for 2025:*
- J & J survey will file the replat application in early February. Once approved, they will complete the paperwork and file the de-annexation/annexation applications.
- Once the jurisdictional issues are nearing resolution, we will consult again with legal counsel and finalize terms of sale with Chalky Mountain Gymnastics.
- Hosanna! and Chalky Mountain will sign a letter of intent, allowing Chalky Mountain to begin feasibility studies, secure financing, and begin engineering plans.

### **SABBATICAL UPDATE**

A pastoral sabbatical might be a new concept for many people. However, sabbaticals are not new to the church or the world. They have been common practice a long time for academics and executives (neither of which I pretend to be). For the church of the past, similar goals were met with different approaches and different names.

Sabbatical time is intended to benefit me *and* the congregation. As I mentioned in my report, ministry is challenging and changing, so **sometimes we both need to turn off autopilot**, **take a step back from the daily grind, and reorient.** Sabbatical is a time to remember what is important, replace draining habits with life-giving ones, listen to God, grow, and be renewed for ministry together.

**Sabbatical is more than time off or vacation for me. It will have a plan.** It will involve giving more attention to my own relationship with God, taking sabbath rest, reading the Bible for myself, improving relationships with the family and friends who sustain me, learning new things, being creative, and contributing to the wider church through passion projects. These activities will help me step back into ministry with a stronger heart, empowered spirit, fresh eyes, healthier habits, and renewed enthusiasm.

Your sabbatical will have a plan, too. Rather than just hanging on until I return, you'll have meaningful activities and pastoral support. I want to emphasize that last point--we will have a loving, caring pastor who will walk with you through any ups or downs while I'm away (along with all your other Hosanna! friends who know you, love you, and will be with you). You will continue to have meaningful worship (after all, it's really about God, not my sermons), and hear different perspectives on God. Our Sabbatical Committee and Council will have also made plans for special events and guest speakers (we're working on bringing the KC Wolf to Hosanna!). You'll spend intentional time thinking about our ministry, too, and be able to talk about challenges and ideas that are hard to bring up or even think of when the pastor is the room.

I am privileged to be a *part* of Hosanna, but YOU are Hosanna! Although I will step back from ministry with you for 8 weeks this summer, I am confident God will continue to work and move through you the whole time.

Thank you for daring to embark on this journey of renewal with me. When we get back together afterwards, we're going to have a lot of new energy, insight, and love to share with one another and empower the next chapter of our ministry.

### **PROPOSAL FOR YOUTH COUNCIL MEMBERS**

**Background:** These resolutions are being presented by the Nominations Committee. Hosanna! encourages everyone to be full and active participants in the life of our community, regardless of age. Additionally, around 25% of worship attendees are under the age of 19. Some individuals may be ready to assume responsibilities at a younger age. Because responsibilities and opportunities in a youth's life are not the same as those traditionally considered in selecting people to serve in church leadership roles, we might overlook them and thereby deprive the community of their gifts. Typically, we have invited "adults" (post-high school) to serve on our Congregation Council. Confirmed members who have not yet graduated from high school could be selected, but often have not been considered because regularly shifting social and educational opportunities that are normal for them, making it difficult or impossible to make the two-year commitment required for council membership. In this recommendation, we suggest the creation of "Youth Council Member" position (s) with a 1-year commitment so that we might consider these members for the sake of our community of faith and for them to have another opportunity to be more fully involved in the life of the church.

### <u>Moved:</u> Hosanna! amend our Congregation Constitution with these Continuing Resolutions:

- **[C12.01.A25]** Up to two additional "youth" may be elected to the Congregation Council in addition to the maximum of 5 non-officer members dictated in C12.01. However, this provision does not preclude a youth from serving as a voting member of the Congregation Council in one of the 5 regularly designated positions with a 2-year term. A Youth Council Member must be a voting member of the congregation who is 19 years of age or younger at the beginning of their term. This position may or may not be filled annually depending on the availability of nominees. All conditions, procedures and responsibilities pertaining to a council member shall apply to Youth Council Members, unless otherwise provided for in this constitution or by applicable state statute or law.
- **[C12.02.A25]** Those elected to serve as a Youth Council Member shall be elected by written ballot, presented on ballots as "Youth Council Member," to serve for one (1) year or until their successors are elected. Such members shall be eligible to serve no more than four (4) full terms consecutively. Their terms shall begin at the close of the annual meeting at which they are elected.
- **[C12.03.A25]** Should a Youth Council Member's place be declared vacant, the Congregation Council may elect, by majority vote, a successor until the next annual meeting, or they may leave the position vacant until the next annual meeting.
- **[CI2.04.A25]** To further the goal of involvement of all members of HOSANNA! in the accomplishments of the mission of the Congregation, and to set an example of good leadership the Youth Council Member(s) shall be available to be a liaison to committees of this congregation as invited, and available without the responsibility of regular participation or leadership. The youth council members shall serve as liaison to the high school youth group of this congregation.
- [C12.12.A25] The Youth Council Member positions will not be included in the calculation of quorum for the transaction of business by the Congregation Council.
